About CENTR

- An international association of ccTLD Registries.
- Started as RIPE project in March 1998 (TLD WG).
- Became non-profit organisation in June 1999.
- Small secretariat based in Oxford, UK.
- European focus, but no geographical limits.
- ccTLD representatives form General Assembly.
- Currently 33 Full Members, collectively register over 7.5 million domain names (over 2/3 of global total for ccTLDs)



Main Aims

- · Forum to discuss matters of policy affecting ccTLDs.
- Acts as channel of communication to Internet administrative bodies & other organisations.
- Promotes interests of non-profit ccTLDs and lobbies on their behalf.
- Focal point for enquiries about ccTLD practices.
- Document policies and practices of ccTLDs.
- Encourage harmonisation of practices and improve service.





Legal & Regulatory Activities

- Managers & registry lawyers participate
 - Smaller WGs formed to look at specific issues
- Examining results of CENTR Survey
 - Data protection, registration policies, Whois
- · Alternative Dispute Resolution
 - looking at ccTLD version of the WIPO UDRP.
- ccTLD Best Practice
 - CENTR Best Practice Guidelines adopted by members 2/6.
 - Mechanism to receive wider input and improve the document
 - Registries encourage to sign up to the guidelines.



Legal & Regulatory Activities [2]

- · Contract for services
 - Formalisation of relationship with ICANN
 - Guarantees on root services
 - Redelegation procedures
- Cybersquatting /domain name warehousing.
 - US legislation being examined
 - EU urging legislation in member states
- EU issues
 - Single market rules, competition issues, Data Protection directive



Technical Activities

- Transfer of name records out of RIPE Database
 - Was accounting for large percentage of total entries.
 - ccTLDs moving towards operating own Whois servers.
- Intelligent Whois Service
 - Web interfaces with back-end intelligence (e.g. Uwhois).
 - Referral records in DNS (e.g. SRV + intelligent clients).
- DNSSEC
 - NLnet Labs conducting scalability tests.
 - 1 year pre-production trial with secure zones.
- Internationalised DNS (ability to use local characters)
 - Monitoring IETF iDN working group



Domain Name Registration Forum

- Open forum for registries, registrars & registrants.
- Inform wider Internet Community of CENTR activities.
- Provide CENTR with feedback on how services might be improved etc..
- 3 meetings per year @ RIPE events.
- · Work areas identified:
 - Common Registration Templates (e.g. XML).
 - Access to zone files & data protection issues.
 - Registry information (part of CENTR Survey).
- Mailing list <dnr-forum@lists.centr.org>



CENTR Survey

- · CENTR is documenting registry structure & practices.
- 25 responses so far (from 33 members).
- Considering extending survey to all ccTLDs.
- Useful for:
 - Technical standards
 - General Informational purposes.
 - Development of 'best practice'
 - Understanding legal structures and relationship with governments in relation to Agreements with ICANN



ccTLD Constituency

- Informal group open to all ccTLD Managers
- Administered by representatives from the 5 regions recognised by ICANN:
 - N. America, Latin American and Caribbean, Europe and Asia
- Also provision for any affiliation of 10+ ccTLDs
 - Currently IATLD
- · Constituency meets at INET & ICANN meeting
 - Matters of policy
 - electing representatives
 - Technical workshops





Relationship with ICANN [2]

ccTLD Managers want:

- Agreements with ICANN
 - Stable & secure DNS Quality Root Services
- Assurances on delegation/re-delegation of the TLD
 Many see a lightweight role for ICANN in respect of ccTLDs
- ccTLD regulation coming from Local Internet Community including government
- Most want a direct relationship with ICANN (not only via DNSO) possibilities include:
 - Separate Support Organisation for ccTLDs Seats on the ICANN board

 - ICANN propose re-introducing a TLD forum IANA functions



Relationship with ICANN [3]

GAC Committee see:

- · A triangular relationship:
 - A form of communication between government and the ccTLD manager establishing 'authority'
 - ICANN to seek confirmation from the government before entering agreement with a ccTLD manager
 - Agreement between ICANN & ccTLD Manager which can be terminated at the request of the government



Relationship with ICANN [4]

ICANN want:

- Agreements with ccTLDS:
 - A condition of the transition agreement with US Government
- Funding
 - 99/00 ICANN requested that 35% (\$1.49m) of their budget come from global ccTLDs
 ICANN issued invoices for 99/00 based on Domain name

 - numbers

 Many ccTLD registries rejected the invoices on the basis that agreements not yet reached

 Where possible voluntary 'donations' are being made with CENTR members donations totalling around \$850,000



Relationship with ICANN [5]

Key issues in making a contract for services:

- Can ICANN guarantee Roots services?
 - As yet, no agreements with Root Server consortium
- Delegation/re-delegation
 - Authority of existing Managers (IANA/Jon Postel/RFC 1591)
 - Small minority of disputed registries
 - ICANN do not want to risk litigation over redelegation (changes currently go the US DoC for approval)
 - Triangular relationship puts responsibility with the governments
- Jurisdiction & applicable law:
 - ICANN established under Californian law
 - differing legal systems throughout the 240+ ccTLDs
 - Perhaps California law with ICC style arbitration?



Relationship with ICANN [6]

Recent developments:

- Meeting of EU GAC representatives, registry managers, CENTR & ICANN staff in Brussels 13/9
 - Highlighted difficulties of a one-size-fits-all solution
 - Problems with proposed letter to be sent by ICANN to governments authorising the registry in their country.
 - Some registries GAC compliant (registry status enshrined in law or run as a government department)
 - Most registries not GAC compliant (private companies, foundations or associations where government has no legal basis to authorise without introducing legislation which could take years.



Relationship with ICANN

Recent developments:

- Two-tier approach now being suggested
- Letter from ICANN in which governments can either
 - 'authorise' a registry (GAC compliant) or
 - confirm 'no objection' to an existing registry (non-compliant)
 - Two contract options between ICANN and ccTLD Managers
 - GAC compliant registries receive minimal regulation from ICANN, on Local Internet community/government for regulation and re-delegation
 - Second contract where ICANN provide a regulatory role in accordance with existing RFC1591 principles



Relationship with ICANN

Recent developments:

- CENTR Legal Group have made a draft contract
- · Meeting sought with ICANN staff
 - To discuss potential contract wording
 - To review progress with letters to governments
- CENTR to hope to have progress in advance of the ICANN meeting in LA,11/00 when:
 - Global ccTLD community meet
 - Government Advisory Committee meet
 - ICANN board meeting to be held.



Creation of .EU

- Consultation process including open meeting, 28/3
 Report on CENTR findings submitted to EC:
 Welcome the e-Europe initiative.
 Support in the community for .EU TLD.
 Concerns at lack of detail in EC proposal.
 CENTR experience/expertise in registry management offered in development of detailed proposal options.

 EC Steering Committee and WGs, with CENTR participation, to make a more detailed proposal 4/00
 Communication to the ELL partiament 7/00.

- Commission now seeking EU approval for EU proposal for EU partiament 7/00 ICANN respond to Commissioner's request for .EU 7/00 ICANN board resolution to accept 2-letter codes from ISO 3166 reserve list (permitting .EU to be a ccTLD) 9/00 Commission now seeking EU approval for .EU proposal
